GENERAL INFORMATION

1. A day is a 24 hour period or portion thereof. Weekend use will mean arrival at 6 p.m. on Friday **at the earliest** and departure at 2 p.m. on Sunday **at the latest**. Week long use will mean arrival at 2 p.m. on Saturday and departure at 1 p.m. on Sunday.
2. The waterfront and campfire circles are common areas. Time allotments for use must be worked out with groups in camp. No other campfire areas are to be used or otherwise created regardless of past practices.
3. Tentative bookings of the camp may be made by phone. Bookings are not to be considered confirmed until this application has been forwarded to the Provincial Scout Office at 6232 Quinpool Road, Halifax NS B3L 1A3 and an approved copy has been returned to the applicant.
4. Water and toilet facilities are not available from October 15 to June 1.

DEPOSIT POLICY

A deposit of \$50.00 **must** accompany the application. The deposit of \$50.00 is non-refundable and will be applied to the fees due. Unless a notice of cancellation is received in the Scout Office, by phone, fax or in writing, 30 days before the date requested to use Camp Nedooae, the deposit will be forfeit.

The camp committee reserves the right to pass on any costs for the removal of garbage or repairs incurred by due to the respective/appropriate camp use.

PLEASE READ BEFORE SIGNING:

In making this application, I acknowledge having read the camp rules and regulations, including the general information on the reverse side. I agree to abide by the camp rules governing the use of the camp and accept responsibility for any damage done to the camp by members of our group, for ensuring the camp is properly closed and locked up upon departure and for removing any garbage from the camp premises. I will submit the required report form and appropriate fees within ten (10) days following the completion of our activity.

KEYS MUST BE RETURNED TO THE SCOUT OFFICE ON THE MONDAY IMMEDIATELY FOLLOWING THE WEEKEND OR THE NEXT DAY FOLLOWING DEPARTURE FROM CAMP.

Should our application for use be granted, we acknowledge our use is entirely at our own risk. Scouts Canada, Nova Scotia Provincial Council will provide no supervision on the site. Supervision of the use and of all activities is entirely our responsibility. We release Scouts Canada, Nova Scotia Provincial Council, its servants, agents or employees (collectively referred to as "Scouts Canada") from any claims arising out of loss or injury to persons or property incurred at the Camp whether or not the claim arises because of negligence of Scouts Canada and agree to indemnify and hold Scouts Canada harmless in respect to any such claim.
